

MyCyclothon 2020 Registration Guidelines and Rules

By registering electronically or physically, the Participant hereby agrees to the following:

- No participant shall be allowed in the event without valid registration, and everyone must wear their entry number bib.
- Registrations under each category is open ONLY for individual entries i.e. no group registrations are available.
- Only an individual and their family members can register for MyCyclothon using a single e-mail id.
- Once registered, the Participant cannot cancel his/her registration and there will be no refund of the registration fees paid by the participant in case of his/her failure to participate in the event.
- In case of any errors in providing information in the registration form, the applicant will need to fill the Entry Form and register again. The fees paid at the time of previous registration shall not be refunded. Therefore, the participant must double check the details filled before submitting the form.
- It is mandatory for all participants to personally collect his/her BIB number.
- In case of unavoidable circumstances, the participant can send a representative to collect the bib on his/her behalf. The authorized representative must carry with him/her (a) website confirmation (b) photo-identity proof in original (Aadhar card, PAN card or passport) of the representative and the confirmed participant.
- Drafting other vehicles/surrogate racers or not completing the entire course will result in disqualification.
- There shall be no support/service vehicle during the race.
- Personal support vehicle is not allowed nor will it be given on track by the organizers.
- Cycling is an adventurous activity and accidents can happen in spite of taking utmost caution and care. The MyCyclothon will not be responsible for injury/accident/ casualty to the participants.
- Any damage caused to the Cycle provided by organizers will be Chargeable*
- It is mandatory for the Participant to comply with the T & C of the Event put forth by LVPEI, Bhubaneswar, and any other rules stipulated by the Event Organizer.
- The Participant must act in a professional and cautious manner while participating in the Event. Failing to do so may disqualify the Participant from the Event. The function of the volunteers and relevant signage at the venue of the Event is only to indicate direction. It is for the Participant to decide if the movement is safe. The Event Organizer shall not be responsible for the same.
- Throughout the duration of the Event, the Participant is required to participate in the Event entirely at his/her own risk, to rely on his/her ability to deal with hazards, and to conduct himself/herself in a manner that is safe for all.
- During the participation in the Event, to cycle with care and attention and abide by the T & C, the local traffic rules, and any other rules stipulated by the Event Organizer.

- The Participant understands that the participation in the Event is physically strenuous and demanding, and that he/she is aware of the nature of the Event and associated medical and physical risks. The Participant further certifies that he/she is physically capable of participating in the Event and completing the Event within the cut off time (as decided by the Event Organizer). The Participant shall take part in the Event only if he/she is fit enough to do so.
- If the Participant has any medical condition(s), including allergies, which the Event Organizer or Event medical advisers need to be aware of, he/she shall disclose the same to them before participating in the Event and he/she shall be solely responsible for any risks involved due to such medical condition(s).
- The Participant accepts complete liability and responsibility for any medical expenses that may be incurred as a result of training for and/or participating in the Event.
- The Participant accepts that the Event Organizer, the Event sponsors, partner organizers, officials, medical advisers or any person involved in the organization of the Event shall not be liable for any injury or illness that he/she may suffer as a result of his/her participation in the Event, whether prior to, during or subsequent to the Event.
- Whilst the Event Organizer shall take reasonable care with the staging of the Event, the Participant accepts that he/she must take all reasonable precautions for the safeguarding of his/her person and/or property during the participation. The Participant further acknowledges that personal accident and personal item insurance is his/her sole responsibility.
- To provide and/or use a suitable bicycle and helmet. The Event Organizer's decision as to whether the bicycle and helmet are suitable or not shall be final.
- The Event Organizer reserves the right to amend the Event format or cancel the Event due to health and safety reasons, including storm, rain, inclement weather, winds or any other act of God or any other Force Majeure Event. In such circumstances, the Entry Fee (if any) paid by the Participant shall be refunded (maintaining the online transaction modalities by registration portals).
- The Event Organizer reserves the right to create, edit or amend the administration charge per Event at any time. This includes the period between the date of entry opening and closing for the Event.
- Confirmed entry to the Event is dependent upon a fully and accurately completed online or physical Entry Form; and receipt of payment of the Entry Fee on or before the specified date. If either of these conditions is not fulfilled, then the entry may be invalid, and the Participant shall no longer be eligible to participate.
- Through the completion and submission of the online Entry Form, the Participant agrees to pay for the Event entry.
- The Participant consents to his/her appearance in any media format, in relation to the publicity of the Event, and in future publicity and advertising of LVPEI or any other event provided that such use does not amount to direct endorsement of any official sponsor or supplier of the Event. The organizer reserves the right to use of pictures of participants for promotion of cause and any event in future.

- The Participant's personal details (including but not limited to name, age group, gender, race category, finishing time, finishing position) shall be stored electronically. Such information may appear on the public list of participants and the results list for the Event. By entering the event, the Participant, consents to access to his/her data by the Event Organizer.
- You will participate only in the race category for which your application as well as entry has been confirmed. No matter what the circumstance is, your cycling and entry number bib will not be transferred to any other person.
- Cyclists, who interchange their timing bib tag and / or number bib tag with another individual will be disqualified from the cycling event and will not be allowed to participate or apply in subsequent editions.
- LVPEI Bhubaneswar holds the right to exclude or disqualify any person from the cycling competition if details filled on the Entry Form are found to be incomplete or incorrect, who is suspected of consuming any kind of banned substances, or who has been banned from competition under jurisdiction of Cycling Federation of India (CFI). It is important to know that no fee will be refunded.
- Please note if you don't wear your timing bib tag as instructed, you won't be able to get an official Finish Time and thereby the official Certificate recording your Finish Time. No Entry Number Bib Tag – No Finish Timing – No Prize Money.
- Prize money is applicable only for timed rides.
- Those who are participating in the event are not allowed to cycle with children or babies who are under age in the designated category.
- Specific finish cut-off timings are there for each category of the race about which participants will be updated on a day closer to the event. Participants who fail to finish their race within the specific timing should stick to the path for completing the race / lap. However the route will be opened for vehicular traffic after the time intimated.
- Only those participants who are confirmed for the event will be allowed on the cycling route. Anyone found wearing no entry number bib or incorrect entry number bib will be immediately removed by the security and disqualified.
- In addition, every participant must wear the entry number bib on the front of their vest. Any damage, mutilation, alteration and fold to the bib will lead to disqualification of the participant from the cycling event.
- Organizers of the event hold every right to stop any participant from participating in the event who is medically unfit, and cannot continue.
- Participants are requested to reach the venue without any belongings. This is to ensure the security of the participants and audience alike. It is strongly suggested that you leave no belongings such as watch, mobile phone, jewelry, electronic gadgets and camera in the bag. The Event Organizers are not responsible for any kind of loss or damage occurring to your belongings. You are responsible for the security of your belongings.
- All decisions by the Event Organizer, its employees or its agents shall be considered final.

- The T & C and any dispute or claim arising out of it, or in connection with it, or its subject matter or formation, (including non-contractual disputes or claims) shall be governed by and construed in accordance with the laws of India. Therefore, the courts of India shall have exclusive jurisdiction.
- A person who is not party to these Terms and Conditions shall not have any rights under or in connection with these T & C.

Prize Money and Regulations:

- Along with the information mentioned herein, the entitlement to prize money as well as finish positions are subject to all the following points.
- Bib tag timing which is captured as well as recorded across all timing points at the time of the race, comprising the start, intermediate as well as finish mats,
- Physical verification which is performed by technical officials.
- Cyclists, who have interchanged or exchanged their Entry Number Bib Tags or cycling number bib with another participant, will be disqualified from the event. Such cyclists shall be entitled to neither prize money nor timing.
- Winners of the prize might be further asked to submit age or identity proof as per the requirement of the Event Organizer for disbursing the prize money.
- The Results which are announced on the day of the event are provisional. Entitlement to prize money as well as final results shall be subject to the rules which are mentioned here.
- The Money won as prize is entitled to Indian Income Tax Rules as applicable, as well as taxed, if any.
- In the eventuality of any dispute, i.e. timing, position, disqualification and distribution of prize money, the decision of the Event Organizers is final.
- The Routes are provisional, distance and elevation may be subject to change.
- Helmets are compulsory for all the participants.

- 1) Helmets are COMPULSORY.
- 2) Kids must be accompanied by an adult taking their RESPONSIBILITY.
- 3) You know your own ability levels and those of your children and are in the best position to decide if they can tackle a ride.
